Dear Mr. Secretary-General:

The People of West Papua are of the Pacific race and have closer affinity and share common customs and traditions with the people of Papua New Guinea, Solomon Islands, Vanuatu, Fiji, New Caledonia, Australia, Cook Islands, Federal States of Micronesia, Kiribati, Nauru, New Zealand, Niue, Palau, Republic of Marshall Islands, Samoa, Tonga and Tuvalu and/ or West Papua is part of Pacific region.

General Assembly adopted Resolution on Enhancing United Nations Cooperation with Pacific Islands Forum refer to UN Resolution :GA/12168, 1 August 2019, in which West Papua is part of Pacific Islands Forum and recently the 50th summit of the Pacific Islands Forum was held on August 13 -16, 2019 in Tuvalu and Pacific Islands Forum Leaders strongly support West Papua issues and has put this into its communique. We seeking the support of member countries of the United Nations to recognize us and grant us our application for membership to the United Nations.

We have made the Public Announcement of the formation of the Provisional Government of the State of the Federal Republic of West Papua as follows:

On this day, Monday, Four of February, Two Thousand Nineteen, as Prime Minister Head of Government together with the President and Papuan People's Representative Council on behalf of the Papuan People, nation and state, and with the blessing of GOD, we make Public Announcement of the Formation of the Provisional Government of the State of the Federal Republic of West Papua, with reference to:

- 1. Montevideo Convention on the Rights and Duties of States, December 26,1933,
- 2. UN Charter, January 1, 1942, Chapter II, article 4: no 1 and 2
- 3. UN General Assembly Rules and Procedure 134,135,136,137 and 138
- 4. First paragraph of the Preamble to the Indonesian Constitution of 1945

- 5. First Papuan People's Congress of 1961,
- 6. Second Papuan People's Congress, May 29 to June 4, 2000,
- 7. Third Papuan People's Congress, October 16 to 19, 2011,

That according to the Papuan People's Mandate through the Third Papuan People's Congress and since October 19, 2011 until today, Monday, February 4, 2019, approximately 7 years, with really hard work and careful consideration, we are forming the Provisional Government of the State of the Federal Republic of West Papua and administer the Provisional Government from Central government to Local government as follows:

- The Central government consists of 23 Cabinet Ministers and State and Government Institutions
- 2. Local government consists of 10 Provinces, 89 Regencies and 10 municipalities.
- 3. 3 Special Areas

Hereby we strongly urge all people of the world, all states, all governments, and International fora to understand, to know, to respect, to appreciate and to recognize the rights of peoples, nations, states, and governments.

The State of the Federal Republic of West Papua will give guarantees to Indonesian people and Foreigners who wish to become citizens of West Papua and ensure their safety and freedom from the point of independence onwards.

The State of the Federal Republic of West Papua is a peace-loving State which accept the obligations contained in the present UN Charter and able and willing to carry out these obligations.

That further recognition and the transfer of the Power from the State of Indonesia to the State of West Papua shall be carried out in an orderly transition in PEACE under the auspices of the United Nations Peace Keeping Force.

We are in control of almost 80% of the territory of West Papua from Indonesia in accordance with Montevideo Convention on the Rights and Duties of States, December 26, 1933 and would like to take over the power in peace under the auspices of the United Nations Peace Keeping Force.

The State of the Federal Republic of West Papua is a peace-loving state which accept the obligation contained in the present UN Charter. We are able and willing to carry out these obligations In that spirit, we also urge the Security Council to appoint a senior official with responsibility to pursue the creation of a senior level negotiation between the government of President Joko Widodo and Leaders of the Provisional Government of the State of the Federal Republic of West Papua and to be mediated by a UN Security Council representative which will result in a recognition and orderly and Peaceful transition and transfer of the power from the state of Indonesia to the State of West Papua and to be carried out under the auspices of the United Nations Peace Keeping Force.

In addition, we are enclosing a book "the provisional government of the State of the Federal Republic of West Papua.
